**Superintendent's Report:** Mr. Campbell spoke about it being a year since the Covid-19 pandemic began and things began to shut down last year. After a long year, things have greatly improved in the last few weeks. There have been no new Covid cases reported at the school since February 12<sup>th</sup> and the 74107 zip code is now in the 'green zone'. As of now, the Prom will still be held on April 16<sup>th</sup> and Graduation will still be held in May but planning to rent the entire Mabee Center to still allow for distancing between groups of people to be on the safe side. Teachers and staff who wanted a Covid Vaccination were able to get their first dose last Friday at Sand Springs High School and should receive second dose in about 4 weeks. Parent Teacher Conferences will be held virtually or by phone this Wednesday and Thursday after school with no classes on Friday. The Wengage Guardian Portal has been made available for parents to begin using. Can use 1 login to view all their children's school accounts instead of having separate logins for each child's account. State testing will move forward even though this school year has been difficult for student learning. Students have to be tested but results won't count against student/school this year.

**Financial Report:** School originally received \$382,000 in ESSER funding and received and additional \$266,000 in ESSER II funding last week that was allocated to schools who received less of the original ESSER funds. Mr. Campbell will consult with the incoming new superintendent about how to spend the new funds.

**Hearings and Correspondence:** Mr. Fox presented a 7<sup>th</sup>-12<sup>th</sup> Drop-Out Report and stated there were no drop-outs for the 2019-2020 school year. Counselors at Middle School and High School Counselors work with each student on a Graduation Plan each year to help prevent drop-outs.

There were no requests for public participation at this board meeting.
