Financial Report: Mr. Batt gave a year to date financial report. Payroll: For December \$635,000, \$588,000 last year. Year to date \$3.4 million, \$3.1 million last year. General Fund: Revenue: For December \$856,000, \$870 last year. Year to date \$5.5 million, \$4.6 million last year. Federal collections \$150,000 for December, \$333,000 last year. Receiving money from submitted federal claims is running slower than last year. Expenditures: \$1.2 million, \$1 million last year. Building Fund: Revenue Year to date \$467,000, \$324,000 last year. Interest earnings are up this year. Expenditures: \$184,000, last year \$157,000

Cash Balances: General \$1.7 million, last year \$1.04 million **Building** \$303,000, last year \$167,000. **State Aid:** With the mid-year allocation, state aid is up \$189,000 from last year.

Hearings and Correspondence: Jan Schilling from Patten & Odom CPA's phoned in and presented the 2023 Financial audit to the board. No deficiencies to report. The audit will be voted on at the February regular meeting.
