The meeting was called to order at 6:00 p.m. by board president James Geiger. Board members present were Jack Lollis, Patty Lawson, Gerry Thames, James Geiger and Ronna Taylor Others in attendance were Mark Batt, Julie Belk and Carmen Hollaway.

Superintendent's Report: Mr. Batt let the board know the bond construction projects are moving along this summer. Construction well under way at the South Elementary safe room and just beginning at the North Elementary safe room as well. Also, a ramp in the South Elementary has been replaced and is now ADA compliant. There is about \$100,000 left in the Covid/Nurse's grant from this year. Just learned there could be an additional \$300,000 available for this upcoming year. This grant helps pay for some janitorial services/salaries and nurse's/nurse's aide salaries. Will be getting the new LED field lighting installed at the softball, football, then at the baseball field. The new scoreboard at the softball field has a late August delivery date. The three new activity buses are here. Currently getting the activity bus we purchased a few years ago re-wrapped to match the new ones.

Financial Report: Mr. Batt reported on financial balances to date. General fund 2022: Payroll \$6.8 million, Revenue \$10.3 million, Cash balance \$2.8 million. Building Fund 2022: Revenue \$471,000. All financial numbers are up from last year due to more federal and/or state grant funding received this year. State has approved a flat budget for education, which means no new money to offset any increased expenses. Our state aid collections will be down in the upcoming year as well due to our 3 year high enrollment number being down. Between those we are looking at over \$300,000 less money for the upcoming year.
