The meeting was called to order at 6:00 p.m. by board president Jeff Blair. Board members present were Jack Lollis, Gerry Thames, Patty Lawson, Jeff Blair and James Geiger. Others in attendance were Mark Batt, Julie Belk and Carmen Hollaway.

Superintendent's Report: Mr. Batt informed the board of the upcoming high school football playoff home game at 7:00 on Friday. Mobile tickets will available to pre-purchase online for \$8.38 each or regular tickets will be \$10 each at the gate. He also gave an update on the track project. It is being painted now, will clean up the edges and wait for a stretch of dry, warm weather before a resin coat is applied. The \$300,000 Covid-19 Prevention Grant was approved. Will help cover parts of some salaries, pay for a janitorial service for the rest of the year to help with building cleaning every night since school has been short on janitorial help for some time and help pay for other Covid-19 mitigation expenses. Employees will each receive a \$600 stipend tomorrow which was approved at the August 9th meeting. A walk-through for new classrooms/safe room construction will take place this week before bids for that phase go out later this month. Looking at an increase in our substitute teacher pay and will take that up at the December meeting. Mr. Batt talked about our sanctioned booster clubs, other than PTA and BEF, not having a non-profit status. He will meet with the club presidents hopefully this week about a couple of options for them. Option 1 - the clubs can be brought in under the school's umbrella with all their monies going into a school activity fund then having to follow the school's protocols for purchasing. Option 2 - In December their sanctioned status can be revoked but can be reinstated after they have obtained their own non-profit status. The board will take this up again at the December meeting.

Financial Report: Mr Batt mentioned that the general fund and building fund balances are still running higher than last year due to all the federal grant funding we have received.

Hearings and correspondence: No public participation at this meeting.

First reading of Policy FE (January 2022) Student Transfers. Decided on enrollment caps for each grade. Pre-K -6th - 20 students per teacher, 7^{th} & 8th - 85 students per class, 9^{th} – 105 students per class and 10th-12th – 100 students per class. Will vote on the new transfer policy in December.
