Revenue and expenditures both up due to federal grant money and the spending associated with that.2022 Building Fund cash balance \$285,000, 2021 \$169,000. Have received \$34,000 in Building Fund from the Redbud Grant (marijuana tax) and should receive another \$38,000 in June. General Fund cash balance 2022 \$2.3 million compared to \$1.6 million in 2021.
